Teen Health Connection employs a team of Master's-level trained clinicians that provide outpatient mental health therapy to adolescents and their families. All of the clinicians are licensed mental health professionals that specialize in adolescent development and utilize a variety of creative techniques to build engagement with teens.

4b (Code:) (Expenses \$ 998,995. including grants of \$) (Revenue \$ 108,058.)

Teen Health Connection's doctoral-level clinical psychologists provide Independent Psychological Assessments (IPAs) for children ages five to eighteen who enter into the custody of Mecklenburg County Department of Social Services, Youth and Family Services (DSS/YFS). The purpose of these service-independent assessments is to provide a thorough psychosocial review and inform DSS/YFS as they ensure safety and work to promote healing and optimal development of youth who have been abused and/or neglected.

4c (Code:) (Expenses \$ 531,677. including grants of \$ 7,500.) (Revenue \$)

The organization provides health advocacy and education services to teens in Mecklenburg County and also hosts education seminars on these same issues. In 2025, Teen Health Connection continued work with its Youth Drug Free Coalition, which provides direction related to our alcohol and substance abuse prevention and education initiatives. Community leaders within the coalition work collaboratively to identify and address youth alcohol and substance use to create sustainable community-level change through prevention strategies. The Youth Drug Free Coalition consists of representatives from the following sectors: youth, parents, business leaders, media, school representatives, representatives from youth-serving organizations, law enforcement officers, healthcare professionals and civic and governmental partners.

Applicants are required to live in Mecklenburg County or one of the six counties contiguous to Mecklenburg County in order to be considered. Applications for the scholarship include a personal essay (1,000 word minimum) on how the applicant has demonstrated leadership, advocacy, and service, along with three personal recommendation letters from non-family members.

Completed applications are initially reviewed by a designated group of the

organization's team members, who review all essays and recommendation letters using a standardized rubric to determine finalists for the scholarship. Applications that have been identified as finalists are evaluated by the organization's Teen Advisory Board, which must come to a majority decision on a scholarship nominee. Once a nominee has been selected, a representative of the Teen Advisory Board presents the nominee's application to the organization's Board of Directors, who must vote to approve the nominee and authorize payment of the scholarship award. Documentation of the scholarship review and approval process is maintained by the organization.

Scholarship funds are paid directly to the recipient's school of choice and must be used for qualified educational expenses, such as tuition, fees, books, and required materials. The organization requires the recipient to provide enrollment information, such as student identification number, university e-mail address, etc. prior to releasing scholarship funds to the recipient's school. No scholarships reported on Schedule I were awarded to officers, directors, trustees, key employees, substantial contributors, or other related parties of the organization.
